

PURSUANT to Section 1 of the Improvement Districts Act, R.S.A. 1980, I, DR. STEPHEN C. WEST, Minister of Municipal Affairs, as council for Improvement District No. 17 East, DO HEREBY ORDER THAT:

1. That the lands contained within the area outlined on the attached Schedule "A" shall be declared the Hamlet of Canyon Creek/Widewater/Wagner; and
2. That the boundaries of the Hamlet of Canyon Creek/Widewater/Wagner be established as described on the attached Schedule "A".
3. Ministerial Order No. 813/92 is hereby rescinded.

SUBJECT: ESTABLISHMENT OF THE HAMLET OF CANYON CREEK/WIDEWATER/WAGNER BOUNDARIES

PURPOSE: To establish new boundaries for the Hamlet of Canyon Creek/Widewater/Wagner.

On March 24, 1993 the South Advisory Council for Improvement District No. 17 East received a petition from residents of Asseneau for hamlet status. After review the recommendation was to include this area in the Hamlet of Canyon Creek/Widewater/Wagner boundaries. This matter was discussed with the petitioners by Councillors White and St. Martin.

At their regular meeting of April 14, 1993, the South Advisory Council for Improvement District No. 17 East passed a motion to recommend ministerial approval for new Hamlet of Canyon Creek/Widewater/Wagner boundaries.
