



## BYLAW 95-2

### OF THE MUNICIPAL DISTRICT OF LESSER SLAVE RIVER NO. 124

*Being a Bylaw of the Municipal District to transfer Ministerial Orders and Improvement District Orders to Bylaws of the Municipal District of Lesser Slave River No. 124 in the Province of Alberta*

**WHEREAS**, Order in Council No. 660-94 replaces Improvement District No. 124 with the Municipal District of Lesser Slave River No. 124 effective January 1, 1995; and

**WHEREAS**, the assets, liabilities, rights and obligations of Improvement District No. 124 are vested in the Municipal District of Lesser Slave River by virtue of the provisions of Section 137 of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta, 1994; and

**NOW THEREFORE**, the Council of the Municipal District of Lesser Slave River No. 124, duly assembled, enacts as follows:

1. That all Ministerial Orders and Improvement District Orders of Improvement District No. 124 in effect as at December 31, 1994 as outlined on Schedule "A" attached be and are hereby adopted as bylaws of the Municipal District of Lesser Slave River No. 124 until amended, rescinded, or replaced, where not consistent with the Municipal Government Act.
2. That all other Ministerial Orders and Improvement District Orders of Improvement District 124 in place but not listed on Schedule "A" attached shall be deemed as repealed.
3. That all policies and resolutions approved by the Advisory Council to December 31, 1994 are considered policies and decisions in effect in the Municipal District of Lesser Slave River No. 124 until amended, rescinded or replaced by resolution of Council.

This Bylaw shall come into force and effect upon the 1st day of January, 1994.

Read a first time this 11 day of January, 1995.

Read a second time this 11 day of January, 1995.

Approved unanimously this 11 day of January, 1995 to be presented for a third reading at this meeting

Read a third time and finally passed, this 11 day of January, 1995.
