
IMPROVEMENT DISTRICT NO. 17 EAST

BACKGROUND INFORMATION

The Establishment of The Hamlet of Marten Beach

The Improvement District No. 17 East South Advisory Council passed a motion at their June 27, 1990 meeting requesting that I.D. Administration prepare a Ministerial Order designating Marten Beach as a hamlet.

The purpose of designating Marten Beach as a hamlet is to permit the Improvement District to access funds for road improvements and street lighting, possible future water and sewer servicing and the development of regulations regarding ATV use.

The South Advisory Council, in making the motion, was acting upon a request from the majority of landowners within the Marten Beach Subdivision, who made their desire for hamlet status known by a vote at their May 21, 1990 Marten Beach Cottager's Society Meeting.

I.D. Administration concurs with the recommendation of the Advisory Council to obtain hamlet status for Marten Beach.
