MINISTERIAL ORDER

IN THE MATTER OF THE

IMPROVEMENT DISTRICTS ACT
Being Chapter I-1, R.S.A., 1980

and the

MUNICIPAL GOVERNMENT ACT
Being Chapter M-26, R.S.A., 1980

and the

RESTRICTION OF THE USE OF MUNICIPAL
AND PUBLIC RESERVES IN N.E. 1 AND
S.E. 12, TOWNSHIP 73, RANGE 26,
WEST OF THE 4TH MERIDIAN

IMPROVEMENT DISTRICT NO. 17 EAST

PURSUANT to Section 16 of the Improvement Districts Act and Sections 110 and 112 of the Municipal Government Act, I, RAYMOND A. SPEAKER, Minister of Municipal Affairs, as Council for Improvement District No. 17 East, DO HEREBY ORDER THAT:

1. For purposes of this Order
 - (a) "Municipal Reserve Land" means any land designated as Municipal or Environmental Reserve by the proper subdivision approving authority and located within N.E. 1 and S.E. 12, Township 73, Range 26, West of the 4th Meridian.
 - (b) "Overnight Camping" shall mean any occupancy of the land for a period of longer than TWELVE (12) hours or past ELEVEN (11) p.m.
2. The use of Municipal Reserve Land shall not be used for overnight camping purposes.
3. No person shall alter, destroy or deface any property within the area of the Municipal Reserve Land.
4. Any person who contravenes a provision of this order is guilty of an offence and is liable, upon conviction, to a fine of not less than ONE HUNDRED DOLLARS (\$100.00) and not more than FIVE HUNDRED DOLLARS (\$500.00) and, in default of payment of fines or costs, to imprisonment for a term not exceeding SIXTY (60) days.


