**MINISTERIAL ORDER**

IN THE MATTER OF

IMPROVEMENT DISTRICTS ACT  
Being Chapter I-1, R.S.A., 1980

and

MUNICIPAL GOVERNMENT ACT  
Being Chapter M-26, R.S.A., 1980



TO PROHIBIT THE DISCHARGING OF  
GUNS OR OTHER FIREARMS IN THE  
HAMLETS OF SMITH, FLATBUSH,  
CHISHOLM, CANYON  
CREEK/WIDEWATER/WAGNER, MITSUE,  
MARTEN BEACH, CALLING LAKE, SANDY  
LAKE, WABASCA/DESMARAIS AND  
CHIPEWYAN LAKE

IMPROVEMENT DISTRICT NO. 17 EAST

PURSUANT to Section 16 of the Improvement Districts Act, Sections 110 and 156 of the Municipal Government Act, 1, R.S. (DICK) FOWLER, Q.C., Minister of Municipal Affairs, as Council for Improvement District No. 17 East, DO HEREBY ORDER THAT:

1. The discharging of guns or other firearms be prohibited in the Hamlets of Smith, Flatbush, Chisholm, Canyon Creek/Widewater/Wagner, Mitsue, Marten Beach, Calling Lake, Sandy Lake, Wabasca/Desmarais and Chipewyan Lake located in Improvement District No. 17 East.
2. Any person who contravenes the provisions of this Order shall be liable on summary conviction to a fine of not less than TWENTY-FIVE DOLLARS (\$25.00) and not more than TWO THOUSAND DOLLARS (\$2,000.00) and in default of payment, to be imprisoned for a term not exceeding 6 months.
3. This Order does not apply to:
  - (a) the discharge of guns or other firearms at a site or place where problem wildlife are present and being hunted by a person or persons under the authority of a licence issued for such purposes by Alberta Forestry, Lands and Wildlife; or
  - (b) the discharge of guns or other firearms as allowed under the Wildlife Act for the purpose of the control or prevention of depredation by black bears, or as authorized by or under the Agricultural Pests Act.
4. This Order shall come into effect on the date of its signing and hereby rescinds Ministerial Order 769/92.


